### Privacy

### Membership

1. Membership is activated when we receive from you a completed application form and payment. A receipt will be issued upon receipt of payment for a full twelve (12) month subscription.
2. Membership is for one (1) year commencing on the date your application is accepted, and is renewable on the anniversary of that date for a subsequent year.
3. Unless accessing monthly direct debit facilities, all membership fees must be paid annually in advance.
